8	<p><b>Planning Applications – to record the councils response on the following applications and consider any further applications received between the publication of the agenda and the meeting.</b></p> <p><b>a) PA21/00738 Mr &amp; Mrs F Marshall, North Bosent Farm, Trelvelmond - Proposed extensions, swimming pool, garage and plant room (deferred from last meeting for more information). No further information received.</b></p> <p><b>b) PA21/01379 Mr T Rogers, Little Valley Cottage, Penfrane Farm, Herodsfoot – Proposed two storey extension on the North East elevation.</b> Support, proposed by Cllr G Crabb, seconded by Cllr D Mills and agreed by the majority. Cllr H Knapman declared an interest and abstained.</p> <p><b>c) PA21/02349 Proposal For clarity this application seeks to 'amend condition nos 3 and 19 of PA19/01517 to allow more time to complete the restoration of Connon Bridge landfill site (until 30th June 2021, with any outstanding tree planting completed by 31st December 2021)' due to a delayed restoration start in 2020 as a result of the COVID-19 pandemic. The description of development on the existing planning permission PA19/01517 is as follows: Proposed further development of the existing operational Connon Bridge landfill waste management facility with variation of condition nos: 2, 3, 4, 10, 11, 13, 15, 23, 31, 32, 33, 35, 36, 37, 38 and 40 of PA12/06980 seeking revised (reduced level) contours and revised restoration strategy including drainage/planting/public access/restoration hours matters with variation of conditions 2, 3, 14, 19 and 33 of decision notice PA20/09255 dated 18.12.2020 Location Connon Bridge Landfill Site A390 Between Junction With B3359 At Middle Taphouse And Dobwalls Roundabout East Taphouse PL14 4NP Applicant Ms Annemarie Wilshaw SUEZ Recycling and Recovery UK. Support, proposed by Cllr D Mills, seconded by Cllr D Stevens and unanimously agreed.</b></p> <p><b>d) PA21/11531 Mr Niall Kelly, Cornwall Energy Recovery Ltd, Waste transfer station, Connon Bridge, East taphouse - Planning application to include the following proposals: Development of new waste reception facility (adjacent and to the north of the existing waste transfer station WTS/ refuse derived fuel (RDF) facility; retention and continued use of the above WTS / RDF facility. Demolition and then redevelopment of the clinical waste facility in new location; Development of a turning head for on site traffic and construction of a fire water tank and pump room and associated infrastructure . All of the above proposed for a temporary period until 31<sup>st</sup> December 2036.</b></p> <p>Application received at the day of this meeting – agreed to hold an extraordinary meeting, if necessary to discuss these proposals. Cllr D Mills to circulate the previously approved letter to residents. It was noted that this application had been submitted to Cornwall Council in December 2020, but not registered for several weeks. Cllr A Jevons felt the amount of information contained in the application was too large to expect anyone to read and submit a response by the 4<sup>th</sup> April 2021. It was agreed the application should be deferred and an extension for a response date requested. Proposed by Cllr A Jevons, seconded by Cllr D Mills and unanimously agreed.
