T1, T2 and T3 (goat willows) – coppice to 0.5m stumps to allow to regenerate.  
T5, T7, T9, T10, T12, T13, T14, T17 and T18 (ash) – all have ash dieback, fell to ground level and replant with sessile oak standards.  
T11 (hazel) – coppice to 0.5m stump to allow to regenerate and clear proximate building.
  - c) **PA23/06127 Florence Cottage, Fore Stree, Herodsfoot – Proposed lounge and diner/kitchen extension.**
