8	Planning Applications – to record the council's response on the following applications and consider any further applications received between the publication of the agenda and the meeting. a) PA23/06053 Higher Penhole Farm, East Taphouse – Construction of detached single storey garage. The Parish Council supported this	

application – proposed by Cllr. Knapman, seconded by Cllr. Jevons, all in favour. b) PA23/06075 Trago Mills, Two Waters Foot – Works to trees subject to a Tree Preservation Order. G1(mixed species) – crown lift trees overhanging service road to achieve 5.2m clearance above road. G2 (mixed species) – coppice group to maintain, and to avoid minor branches interfering with building roof. T1, T2 and T3 (goat willows) – coppice to 0.5m stumps to allow to regenerate. T5, T7, T9, T10, T12, T13, T14, T17 and T18 (ash) – all have ash dieback, fell to ground level and replant with sessile oak standards. c) T11 (hazel) – coppice to 0.5m stump to allow to regenerate and clear proximate building. The Parish Council supported this application – proposed by Cllr. Knapman, seconded by Cllr. Jevons, all in favour. Clerk d) PA23/06127 Florence Cottage, Fore Street, Herodsfoot – Proposed lounge and diner/kitchen extension. Having looked at the proposals and speaking with the applicant, the council resolved to request the date for comments be deferred to give the applicant more time to submit further details on the materials etc. Proposed by Cllr Stevens, seconded by Cllr Jevons and unanimously agreed. e) To note any pre-applications submitted to Cornwall Council (the Parish Council are not asked to comment on this type of application) and receive any application decisions.
