1	Public Session for items on the agenda (10 minutes). Meeting then closes to the public, but parishioners and visitors are welcome to remain if they so wish. There were no members of the public present.	
2	Apologies for absence were received from Cllr D Stevens.	
	At this point of the meeting the Chairman read a letter of resignation from Cllr D Mills with effect from this meeting. Councillors thanked Cllr Mills for his work and he was presented with a clock in recognition of his dedication to St Pinnock Parish Council.	
3	Members Declarations of Interest on items on the Agenda. None declared at this stage of the meeting.	
4	Report from Cornwall Council – Cllr J Pascoe reported the full council meeting was the following day on the 16 th April 2024. The new household waste and recycling collections had started and would gradually roll out across all areas of the county. Cllr Pascoe reported on the Cornwall Council planning committee meeting that refused the site at Trago Lane (application number PA23/09811). Enforcement would now start.	
5	To approve the Minutes of the Meetings held on the 18 March 2024. The minutes of the meeting held on the 18 March 2024 were approved and signed by the Chairman. Proposed by Cllr Knapman, seconded by Cllr Dingle and unanimously agreed by those who attended.	
6	Matters arising from the Minutes. Item 14 Local projects. Cllr Dingle suggested Councillors canvas their local areas to see what parishioners wanted, with information being placed on the parish magazine and council websites.	
7	Accounts / Financial Matters – a) To approve the accounts presented for payment. The council approved the payment of accounts presented. Proposed by Cllr Jevons, seconded by Cllr Spear and unanimously agreed. Ch 1064 J Hoskin – clerks payment / expenses = £ 175.44 Ch 1065 HMRC = £ 40.74 Ch 1066 Western Web – website maintenance = £ 96.00	

	<p>b) To consider quotations and approve costs towards the new Trevelmond notice board. Councillors agreed to accept the resident's choice of an aluminium notice board and agreed to support the costs of a new board up to the value of £950. Proposed by Cllr Dingle, seconded by Cllr Philp and unanimously agreed. The new board would hold 18 x A4 sheets. Cllr Pascoe had also supported the project by agreeing to donate £300 from the Community Chest Fund.</p>	JD

Cllr Mills updated the council on the status of current applications.</p>	
9	<p>Playing Field, East Taphouse -to report on inspections and identify any work required. Cllr Spear reported the swing chains were still being wound around the top bar. The clerk notified of the ROSPA inspection being carried out in April with the report to follow next month.</p>

11	<p>Correspondence to be noted. Noted. The monthly report from the PCSO identified no crimes for the parish between the 1 March 2024 and 1 April 2024.</p>	
12	<p>Connon Bridge Landfill Site – update on matters relating to the site. Date of the next site meeting, 14th May 2024. It was noted that a large pothole had appeared at the entrance to the site, on SUEZ land; lorries were often queuing to get into the site, and Cllr Mills mentioned the discharge of water onto the land.</p>
